




I have made it the priority of the Butler County Sheriff's Office to do everything in my power to protect the children while at school. I have done this by increasing the number of SRO's in the schools, training my Deputies for active shooter response, meeting with school administrators/staff for safety recommendations, increasing daily patrols of school property, and offering free CCW training to teachers/staff.

To date the Butler County Sheriff's Office has provided <u>FREE</u> CCW training to over 175 teachers, and we have placed 22 SRO's in area schools in 5 districts. At the start of my service with Butler County Sheriff's Office we didn't have any SRO's, we have come a long way under my command, but we still have a way to go.

I have been warning everyone for years that we must prepare and try our best to make the schools safer; sadly I was proven right that it can happen here also. As it did, back on February 29, 2016 at Madison High School in Madison Township. We are all thankful that

no one was killed and that we had a Butler County Sheriff's Office SRO in place in that school. If the SRO wasn't in that school, things could have been drastically different.

I feel so strongly about making our schools safer, I have sent letters to the Butler County School Board, made billboards (using my own funds), spoke on national news channels, and expressed my concern to State Legislators. I have publically gone against some people's opinions about arming teachers, but I don't care, we must do everything in our power to protect the children and give them a fighting chance.


Chief Anthony Dwyer was born, raised and continues to reside in Middletown, Ohio. He began his career at the Butler County Sheriff's Office in 1984 when he was hired as a Deputy Sheriff assigned to the Jail. Over the next Thirty (30) plus years he was assigned to the Road Patrol Division before being promoted through the ranks of Detective, Sergeant, Lieutenant, Captain, and Major. When Sheriff Jones was elected in 2005 he promoted Dwyer to his current position of Chief Deputy.

Chief Dwyer is second in command and has the responsibility of managing every aspect of the Sheriff's Office including a budget that exceeds 50 million dollars. While his current position as Chief Deputy is mainly an administrative one, the Chief will readily admit that his passion still lies in the Detective Division. Chief Dwyer stated "There's just something about the nature of the hunt when you're working a case. "It can be very exhilarating".

Major G. Michael Craft graduated from Hamilton Taft High School in 1980. He is a lifetime Hamilton resident and a former Champion Paper employee. He made his career switch to law enforcement when he joined the Butler County Sheriff's Office in October 1989 as an undercover drug agent. After attending the Basic Peace Officer Training Academy, Major Craft was assigned as a Corrections Officer until he was promoted to Road Patrol in June 1991.

After being promoted to Detective in 1996, Major Craft completed three tours in the Drug Unit, was a D.A.R.E. & G.R.E.A.T. Officer assigned to the Crime Prevention Unit and was the first Detective assigned to the newly created "Crimes against the Elderly" program in 1995. In 1996, he was named "Employee of the Year."

After his promotion to Sergeant, Major Craft was assigned to supervise the Detective Division and Drug Unit until his promotion to Lieutenant in 2000. As Lieutenant, he worked assignments in Court Security and the Civil Division and served as Deputy Warden of Corrections for over four (4) years. His final assignment as a Lieutenant was with Criminal Investigations until his promotion to Operations Captain in November 2013.



Major Craft has also been a member of and supervised the Marine Patrol Unit and Hostage Negotiators. With over twenty-eight (28) years of experience at the Butler County Sheriff's Office, Major Craft has worked countless high profile homicides and investigative cases along with county-wide, record breaking drug cases.




On July 24, 2018, Lieutenant Fisher was assigned as the Warden of the Corrections division overseeing the operations of the Main Correctional Complex along with the Resolutions and Court Street Facilities.

Lieutenant Fisher supervises one hundred and seventy-five (175) employees including Corrections Lieutenants, Sergeants, Corrections Officers, Medical, and Maintenance personnel. On average, the Butler County Jail books and releases 13500 inmates per year. The Jail is

always on the lookout for contraband entering the facility so a body scanner

was purchased that can detect drugs, phones, weapons, and anything

that is not permitted.





Medical services are provided to the inmates through our Medical Services Division. Inmates are medically screened upon entering the facility to discern special needs or medication requirements. Inmates who require medical care during their stay may make a request for medical services by filling out a "green slip." The "green slip" is much like an Inmate Service Request. These requests are submitted to the medical staff that then triages them in order to provide timely and appropriate medical treatment. Medical staff performs sick-call visits in each housing unit and medical screening of inmates on a daily basis-averaging sixty per day.

The Medical Service division is comprised of: Health Services Administrator, two (2) Medical Supervisors, medical billing clerk, part-time registered nurse for immigration detainees, four (4) full-time paramedics, seventeen (17) part-time paramedics, one (1) part-time RN, one (1) part-time LPN, one (1) Physician, one (1) Physician Assistant, one (1) dentist, and one (1) full-time clerk. Mental health services are augmented through Transitional Living Inc.







Finance Director Vickie Jo Barger



Director Barger leads the Finance Division of the Butler County Sheriff's Office. The Finance Division oversees all financial, human resources, payroll, inmate accounts, grant administration and purchasing functions of the Sheriff's Office. It directs the annual performance-based program budgets for the office, which includes monitoring expenditures and performance measures, producing financial reports and projections, conducting financial analysis, and implementing fiscal control policies and procedures.

This division represents the Sheriff when presenting budget, fiscal, and contract requests for the Board of County Commissioners for approval. This division also monitors and oversees multiple budgets – six general fund departments and twenty-four non-general/agency funds.

Expenses

The Butler County Sheriff's Office General Fund expenditures, excluding the expenses associated with the Payroll, totaled \$8,739,546 for 2018 and \$7,861,664 for 2017. General Fund expenses including payroll increased 8.6% primarily due to the continuous rising costs of health insurance.

The Sheriff's Office added a new department during 2018 due to new State requirements that require Butler County (identified as a "Target County") to retain fifth degree felony offenders at the Butler County Correctional facility. Most fifth degree felony offenders are prohibited from serving a prison sentence in a State prison effective July 1, 2018. The expenditures for this new requirement are reported in the Incarceration Alternatives account. Expenditures can include incarceration alternatives such as electronic monitoring/GPS services, residential drug/alcohol treatment within the correctional facility, outpatient treatment and/or counseling services.

The Court Street facility was reopened mid-2018 and was at full capacity beginning June 2018. The opening of this facility substantiates the 11% increase in the Boarding of Prisoners category









Payroll

The Finance Division's payroll responsibilities include maintaining, preparing and processing biweekly payroll, tracking all employee accrual balances, pay adjustments, account changes and leave usage records. Payroll staff also performs internal audits of employee payroll records to certify accuracy and completeness. TimeTrak portals have been placed throughout Sheriff's Office facilities which allow employees to check their accruals. Payroll is trended to budget to ensure continuity and compliance with the Butler County Auditor and Ohio Revised Code.

Inmate Accounts

The Inmate Accounts Unit is manned by one full-time Administrative Clerical Specialist. Each inmate has an account assigned to them when they enter the facility in which money is deposited. These funds are used for commissary purchases such as snacks, clothing, telephone cards and special meal orders as well as reception fees, court related fees, attorney fees and/or bond fees. Visitors can deposit money via credit card onto the inmate's account by utilizing the kiosk machine located in the main jail lobby or online and/or calling Access Corrections.

During 2018, the Sheriff's Office installed and implemented new inmate account software along with contracting the commissary with the Keefe Group. When inmates are booked into the jail, any money on their person will be deposited into an intake kiosk which automatically posts to their account. The intake kiosk was installed in 2018 and alleviates the risk of inmate money being lost or posted to the wrong account. Also, as part of the upgrade, a debit card release system was installed that allows the Corrections Sergeant to produce a debit card for the inmate at time of release. This system has reduced the number of written checks to released inmates as well as the number of outstanding checks that do not get cashed, checks getting lost in the US mail and reduces the risk of check fraud. Any balance that remains on the inmate's account at time of release is refunded to the inmate.

The inmates use the deposits for commissary purchases, vending machine purchases (also added during 2018) reception fee, court related fees, attorney fees and/or bond fees. During 2018, the inmate account deposits totaled \$2,088,693 with commissary sales totaling \$1,536,066.


The Butler County Sheriff's Office operates an Aviation Unit with two helicopters - a Robinson R44 Police Helicopter that has been part of the fleet since 2007, and a Bell OH58 Kiowa helicopter that was acquired in 2015. The unit flew the R44 for one hundred sixty (160) hours, and the OH58 for one hundred thirty-five (135) hours, for a total flight time of two hundred ninety-five (295) hours, which is twenty-seven (27) hours less than last year's total of three hundred twenty-two (322) hours flown.

The OH58 was received from the 1033 Program, a Federal program that puts surplus equipment into service with local law enforcement and began operations with the Aviation Unit in April of 2015. It was utilized primarily for the drug eradication contract to help reduce flight time on the Robinson R44 helicopter, thus extending the time before it will be subject to a mandatory overhaul.

Throughout the year, BCSO's Aviation Unit assisted several different law enforcement agencies including other sheriff's offices, police departments, BCI, DEA, ICE, and other county agencies such as the EMA and the Butler County Engineers Office. The assists were for everything from drug surveillance, searches, photo flights, evaluations of the river, memorial ceremony flyovers, funeral escorts, and other requested events and applicable missions.

From August 8th to September 22nd, 2018, the unit assisted twenty-one (21) counties across northwestern Ohio with marijuana eradication. During the eradication effort, the unit found three thousand (3,000) plants with a street value of over three million dollars (\$300.000.00). This was a decrease of plants from the year before. The remaining hours were for everything from drug surveillance, searches, patrol, photo flights, flight training, pilot recertification, and displays.

The unit flew one hundred sixty-eight (168) hours on a drug eradication contract for Ohio's Bureau of Criminal Identification (BCI), the same hours



Drone

The Sheriff's Office has 2 Drone platforms, A Q500 for daytime high resolution images and a H520 with a FLIR and low light camera. After receiving FAA approval, the drone was used to take aerial photos of a crime scene. Unmanned Aircraft System, or UAS, is an inexpensive tool that many law enforcement and fire agencies will be utilizing in the future. The Butler County Sheriff Office is the first agency in the State of Ohio to receive FAA approval for UAS's.



As Dog Warden, Sheriff Richard K. Jones is committed to serving the community by protecting the health, safety and welfare of animals. BCSO's Deputy Dog Wardens are primarily focused on domestic animal issues and the enforcement of dog laws. They are also certified humane officers. Deputy Dog Wardens respond to calls of dogs at large, dog license enforcement, dog bites, and dog attacks. They also assist BCSO Deputy Sheriffs and local police departments with search warrants and selling dog licenses.

Deputy Dog Wardens, as certified humane officers, handle all animal cruelty complaints, neglect cases, and abandonment cases in the County. These cases involve many different kinds of animals from horses and goats to dogs and cats. The Deputy Dog Wardens normally work an eight hour shift; however the job does not stop there. The Deputy Dog Warden unit is on call at all hours for emergency situations as they arise.

In 2017, BCSO Deputy Dog Wardens drove 90,143 miles, impounded a total of two thousand one hundred and seventy one (2,171) animals either to the shelter or back to the owners, wrote one thousand one hundred seventy four (1,174) citations and six hundred forty seven (647) written warnings, handled one thousand one hundred eighty six (1,186) counts of animal cruelty, neglect or abandonment cases, and wrote one hundred twenty one (121) citations for cruelty or abandonment and three hundred eighty six (386) humane warnings. They patrol and cover all of Butler County except the City of Fairfield and the City of Oxford as they have their own Animal Control Officers. BCSO's Deputy Dog Wardens have the responsibility of full time duties in the City of Middletown and the City of Hamilton.











Special Units

Motorcycle Unit

The Butler County Sheriff's Office Motor Unit is comprised of Sergeant Mike Nutt and four (4) Deputies who are utilized for traffic control, routine patrol, and specialized traffic details.

The Motor Unit is used for patrol purposes such as congested traffic situations, funeral escorts, V.I.P. details, shopping center and business patrol, sporting events, parades, various charitable events, and displays at the Butler County Fair.

Other responsibilities Deputy Wargo is responsible for is making appearances at facilities that deal with citizens with mental illnesses and developmental disabilities, making presentations to agencies referencing workplace safety when dealing with the mentally ill, and educating other police agencies on protocol for dealing with mentally ill citizens.










Special Units

Bike Patrol Unit

During 2017, the Bike Patrol was deployed as part of a daily patrol routine, weather permitting. There has been an increase in deploying the Bike Patrol Unit in the Liberty Township area due to having an increase in population and a new Liberty Center Mall. The Bike Patrol, besides their daily routine of patrol is also involved in Parades, School functions; concentrated police presence through high theft area of neighborhoods, Butler County Fair and different bike runs that requires the presence of the Sheriff's office. Bike Patrol Personnel, throughout the year, brought their bikes with them mounted on their patrol units so they can utilize the bikes at any time during their daily patrol.

The Bike Patrol Unit has been in the process of updating all their equipment. At the end of 2016 and beginning of 2017, seven new bikes were purchased for the Bike Unit to replace the older bicycles in the fleet. As the weather breaks the Bike Patrol will be utilized more often patrolling neighborhoods and areas with high calls for service.


